To prove identity, you must show proof of the following five elements: <b>1 - Full Legal Name*; 2 - Date of Birth; 3 - Legal Presence in US; 4 - Social Security Number;</b> <b>and 5 - Ohio Street Address</b> To prove an element, the element must be contained on the document. - Original or Certified Copy of a Marriage Certificate or Marriage License\*\*
- Certified Copy of a Decree of Divorce, Dissolution, or Annulment of Marriage\*\*
- Certified Copy of a Court Ordered Name Change

\*\*NOTE: If you have had more than one marriage, you may need to bring documentation from each marriage and/or divorce to connect your birth certificate, passport or USCIS documents to your current legal name. Permanent Resident Card (Form I-551) must show current legal name
